Chairman Adolfo Henriques called the meeting to order at 12:14 pm. Absent a quorum, Chairman Henriques moved to a presentation by Marte Siebenhar of Bakehouse Art Complex and then to Reports and Discussion Items.

PRESENTATION: Marte Siebenhar, Executive Director, Bakehouse Art Complex

Ms. Siebenhar reported that the 28-year old Bakehouse Art Complex, located in the Wynwood Arts District, is a nonprofit organization providing juried emerging and mid-career artists with affordable studio spaces, exhibition opportunities, educational programming, and common workshop spaces.

The complex is comprised of 70 studios, two galleries, project room, classroom, print room, photo lab, ceramic kiln area, woodworking and welding areas. The Bakehouse received a Knight Arts Challenge Award to upgrade equipment and add a metals foundry for artists who work in large-scale casting mediums.

There are currently 65 artists in residence who conduct artists' talks and teach master classes.

REPORTS AND DISCUSSION ITEMS

FY 2014-2015 Budget Updates

Miami-Dade County

The County Commission's Finance Committee has held meetings at which each department has made budget presentations. Internal departmental budget submissions are being reviewed by the Mayor. There is an approximately \$200 million shortfall in General Fund revenues for the County's FY 2014-2015 budget.

Chairman Henriques has met with Mayor Gimenez, emphasizing not only the economic impact of the arts industry but also the transformational effect on the County. Mr. Alexander noted that it was important for Councilors to contact their individual Commissioner and that there was only a two week window of opportunity to communicate our needs and concerns.

State of Florida

The state legislature approved \$44 million for the arts, the largest allocation in the history of the state. More than 100 Miami-Dade arts groups will be affected.

Culture Shock Miami – Discount Tickets for Youth

Culture Shock Miami will present Rhythmic Circus – *Feet Don't Fail Me Now!*, a highly energetic, tapping explosion of rock, blues, and soul. *Feet Don't Fail Me Now!* has been contracted to perform on the main stage of the South Miami-Dade Cultural Arts Center on June 28, 2014. Additionally, a free, full performance is being made available to Miami-Dade County camps on June 27th and a tap-dance workshop is being offered to Miami-Dade residents on the morning of June 28th. Tickets were put on sale on April 29, 2014 on CultureShockMiami.com. In addition to the \$5 Culture Shock Miami student-rate, a limited number of tickets are available at SMDCAC.org. These tickets will be sold to the general public at a cost of \$15-\$25.

On May 3, 2014, Culture Shock Miami participated in the Center's 8th Annual All Kids Included Festival. In an effort to raise awareness about the program and draw teen audiences to the Center, Culture Shock Miami sponsored the festival's outdoor stage. Outdoor stage performers included 21st Century Steel Band, The Rodiles, and Sons of Mystro. These performers were carefully selected because of their appeal to the program's target audience. In addition to Culture Shock Miami Program Managers Christina Tassy-Beauvoir and Gerry Landreth, a Master of Ceremony promoted the program and promotional materials were distributed to attendees.

Department Facilities Update

Miami-Dade County Auditorium (MDCA)

MDCA produced, in collaboration with Latin Grammy Nominee Jose Negroni, "*Cada Uno Con Su Historia*." In addition to Negroni, featured artists included Armando Terron, Luz Marina and Latin Grammy nominee Saavedra. The artists shared a casual setting on stage as they told stories through song. This work was commissioned by MDCA as part of its On.Stage Black Box series.

TigerTail, in collaboration with MDCA, brought the first installment of the FLA-FRA Festival to MDCA's On.Stage Black Box. Performances featured French cabaret singer Floanne and French choreographer Myriam Gourfink.

"Sotto Voce," by Pulitzer Prize winning playwright and Miamian, Nilo Cruz, played to sold-out audiences.

Joseph Caleb Auditorium

In partnership with the Miami-Dade Public Schools' "Cultural Passport" program, Caleb hosted more than 30,000 students this season. In addition, the auditorium was rented for performances by the New World Symphony and The Arts Power Touring Company presentation of "Heart in a Suitcase."

It is still anticipated that the parking lot serving the Auditorium will be closed to prepare the site for construction of a new parking garage. The conversion of the Auditorium into a venue for school field trip performances could last for two years.

Coconut Grove Playhouse

Mr. Spring reported that the Miami Parking Authority (MPA) is making repairs on the parking lot, including improvements of on-site security.

The Coconut Grove Village Council has put together a committee to track the progress of the Playhouse development and will be meeting for its second public session.

Art in Public Places

Ms. Reddick reported that the project at the Gran Via Apartment Complex has been completed. In addition to the various mangroves, leaves, and bird shape elements covering the chain link fence system, the artist extended the artwork to the surrounding wall plane where a series of two dimensional birds are arranged to resemble a flock of seagulls flying to or from the nearby Everglades.

On Memorial Day, Richmond Heights will dedicate a monument by Gene Tinnie on a triangular green space between Lincoln Boulevard and Madison Street honoring the pioneering veterans of the community.

A "Call to Artists" has been released to develop an artist-designed LED marquee for the African Heritage Cultural Arts Center which will feature announcements for the Center.

DIRECTOR'S REPORTS

- The current vacancy on the Cultural Affairs Council will be filled by Susana Ibargüen who was appointed by District 10 Commissioner, Senator Javier Souto.
- The 8th Annual All Kids Included Festival was held at South Miami-Dade Cultural Arts Center on May 3 with an estimated attendance of between 4,000 to 5,000 children and families.
- Mr. Spring reported that he is contact with the Museum of Contemporary Art (MoCA) regarding the ongoing issues with the City of North Miami and will keep the Council apprised of developments.
- The Miami Science Museum has severed ties with their contractor over unreconciled issues. There is a contractor taking over the project and the objective is for the transition to occur with minimal delay. Mr. Spring emphasized that there will be no additional money required for the project as a result of the change.

Staff member Lisa D'Andrea Thompson is present on the construction site as well as in on all construction meetings.

- Mr. Spring reported that Fairchild Tropical Botanic Garden will provide consultants for landscaping around African Heritage Cultural Arts Center.
- Mr. Spring noted that Chairman Adolfo Henriques was honored as a Pillar of the Community by the Miami Beach Chamber of Commerce.

Mr. Lopez entered the meeting at 1:05 pm. Chairman Henriques moved to Items for Approval.

- Mr. Bao said that it was an honor to be present when Chairman Adolfo Henriques was honored by the Miami Beach Chamber of Commerce for his work at Gibraltar Private Bank & Trust as well as his association with dozens of charitable organizations all over Miami and Miami Beach.
