Project-based Grants – Quarterly Deadlines

COMMUNITY GRANTS (CG) PROGRAM

- Nonprofit organizations developing community-based cultural (dance, theater, music, visual arts) programs, projects and events, such as fairs, parades, neighborhood festivals and publications that have a strong artistic component
- Universities, Colleges, Municipalities, Units of Local Government, Individual Artists (with Fiscal Agent)
- Strong community involvement and/or outreach component
- Sensitive to the needs of indigenous cultural neighborhood activities and projects encouraging the preservation of heritage, traditions and culture, as well as social service organizations and cultural groups developing arts and collaborative intervention projects

Maximum Request

\$7,500 One-time cultural events/artistic projects

\$10,000 / \$15,000 Major, annually recurring projects with a two-year minimum track record such as festivals and fairs drawing 1,000 people or more per day to the event

TOURIST DEVELOPMENT COUNCIL (TDC) GRANTS PROGRAM

- Organizations/events which promote Miami-Dade County's appeal as a tourist destination by sponsoring tourist-oriented sports events, cultural and special events (visual and performing arts, including theater, concerts, recitals, opera, dance, art exhibitions, and festivals) and television origination projects.
- Nonprofit Organizations, Universities, Colleges, Municipalities, Units of Local Government and For-Profit Organizations
- The TDC's objective in funding events is to attract tourists from outside of Miami-Dade County into the area; encourage overnight stays in Miami-Dade County motels and hotels; and perpetuate an environment for growth in the tourism industry in Miami-Dade County.

Maximum Request

\$5,000 Division A Maximum Project Budget of \$50,000

\$10,000 Division B Project Budget of \$50,001 - \$100,000

\$25,000 Division C Project Budget of \$100,001 - \$250,000

\$35,000 Division D Project Budget of \$250,000 and above

Audience Access (AUD) Grants Program	Supports ADA access/technology and services
Capital Development (CAP) Grants Program	Supports capital improvement projects designed to expand, renovate, construct, and/or equip cultural facilities in Miami-Dade County
International Cultural Partnerships (ICP) Grants Program	Support artistic exchanges, partnerships or collaborations with artists, arts professionals and/or organizations abroad
Summer Arts & Science Camps (SAS-C) for Kids Grants Program	Supports arts or science camps in partnership with The Children's Trust
Youth Arts Enrichment (YEP) Grant Program	Supports arts projects for children and/or youth in Miami-Dade County in partnership with The Children's Trust

Artist Access (ART) Grant Program

Maximum Request: \$1,500

Funded by Miami-Dade County and offered in partnership with FUNDarte, the Artist Access Grant Program is designed to assist practicing, professional artists in any medium or discipline residing in Miami-Dade County pursue opportunities that will advance their practice and careers in demonstrable ways. Eligible opportunities include artistic professional development and skill-building opportunities, as well as financial offset of equipment purchase and studio rental.

Deadline: September 2022


Community Grants (CG) Program

Maximum Request: \$7,500

The Community Grants (CG) Program is responsive on a quarterly basis to nonprofit organizations developing small and large-scale community-based cultural (dance, theater, music, visual arts) programs, as well as projects and events, such as fairs, parades, neighborhood festivals and publications that have a strong artistic component. Individuals and unincorporated organizations may apply for project grants under the fiscal agency sponsorship of an eligible, nonprofit, tax-exempt, organization on a case by case basis.

Deadline: June 2022

OPPORTUNITIES FOR INDIVIDUAL ARTISTS

Dance Miami Choreographer's (DMC) Program

The program provides non-matching awards of \$10,000 on a competitive basis to nurture the artistic development of Miami-Dade County-based professional choreographers for the creation of new work in all dance forms, including modern dance, ballet, and folk. Local choreographers, who have an established body of work, are invited to submit work samples for review by a national panel for selection.

Deadline: March 2023

Playwright Development Program (PDP)

The Playwright Development Program (PDP) is a series of two-day workshops conducted by nationally-renowned playwrights in conjunction with the Theatre League of South Florida and the Deering Estate at Cutler. The program is designed to provide intensive support for developing new work from Miami-Dade County's growing and diverse community of playwrights. Local playwrights are invited to submit work samples for review by a panel that will admit a limited number of participants into the series. The PDP Cycle lasts two years and consists of three weekend workshops each year (a total of 6 weekend workshops) with exact dates to be determined.

Deadline: 2023




South Florida Cultural Consortium (SFCC) Grant for Visual and Media Artists

The South Florida Cultural Consortium Grant Program offers the largest regional, government-sponsored artists' grants in the United States, awarding \$15,000 and \$7,500 grants to resident visual and media artists from the counties of Broward, Martin, Miami-Dade, Monroe, and Palm Beach. Since it was established in 1988, the Consortium has awarded over to \$4 million in grants to more than 300 artists. In addition to receiving the grant, the artists take part in an exhibition hosted and organized by a visual arts institution in one of the five counties.

Deadline: October 2022



- Awarded and administered by the Miami-Dade County Department of Cultural Affairs
- Supported by:
 - Miami-Dade County Mayor,
 - Miami-Dade County Board of County Commissioners, and the
 - Miami-Dade County Cultural Affairs Council
- National Endowment for the Arts
- \$500,000 American Rescue Plan (ARP)
- One-time Grant for FY 2021-2022
- Received 600 applications
- More than 200 artists awarded
- We are hoping to renew the program for next year, FY 2022-2023.



Grants Writing Tips

1. Sign up at miamidadearts.org to get announcements about resources
2. Start early!
3. Read the guidelines carefully
4. Attend the mandatory workshops and consultations
5. Draft your application in Word (or similar text software) and paste answers in online portal
6. Make sure your budget numbers match your narrative
7. Develop good quality support materials
8. Use clear and concise language
9. Proofread and ask someone to read a draft
