# FY 2020-2021 Cultural Development (CDG) Grants Program Panel Recommendations

Ms. Adriana Perez reported that the Cultural Development Grants Program, chaired by Council member Mireille Chancy-Gonzalez convened on May 28, 2020 to review 18 applications requesting a total of \$1,080,000. The panel recommended funding all 18 applications. The Cultural Development Grants Program provides general operating support grants and technical assistance to a selected group of Miami-Dade County's mid-sized, artistically accomplished and culturally diverse performing, visual, literary and presenting arts organizations that are defining the cultural and artistic voice of Miami. Qualifying organizations are committed year-round to the creation or presentation of art, within or across artistic fields and disciplines, which demonstrate the potential to achieve regional, national, or international visibility as evidenced by current programs and management structure and many times engage in strategic partnerships for greater artistic success.

## FY 2020-2021 Youth Arts Miami (YAM) Grants Program Panel Recommendations

Francine Andersen reported that the FY 2020-2021 Youth Arts Miami (YAM) Grants Panel, chaired by Cultural Affairs Council member Mitchell Bierman, convened on Friday, May 15, 2020 to review 31 applications requesting a total of \$2,250,000. The Panel recommended funding all 31 applications. The objective of the Youth Arts Miami (YAM) Grants Program is to provide operational funding support to non-profit youth arts organizations having a year-round presence in Miami-Dade County whose primary mission is to create, present or exhibit cultural programs for children and/or with children. Applicants to this program must have at least a three-year track record of providing a year-round season of youth arts activities for children and youth.

#### REPORTS AND DISCUSSION ITEMS

### Coronavirus (COVID-19) Update

Ms. Leslie reported that the moment COVID-19 forced closures in our community, the Department of Cultural Affairs redeployed \$300,000 in Travel/Consultant funds and issued emergency grants to 150 arts groups to provide additional immediate assistance during the pandemic. The Department continues to gather important financial data monthly with the COVID-19 Survey of Impact on Miami-Dade County's Cultural Community. Results for the survey including the month of May, reflect a financial impact of almost \$60 million with 9,799 jobs affected. This information will be used to advocate and elevate the need for recovery resources for the cultural community to be able to mitigate the impact of COVID-19.

# **State Arts Budget Update**

Mr. Winick reported the State of Florida legislature has not submitted the budget to the Governor for his signature. There currently is reluctance to submit the budget for signature until the state has a better idea about how it will be affected because of the downturn in revenues and increases in expenditures due to COVID-19. At the conclusion of the legislative session, \$21.25 million was allocated for the State arts budget. Mr. Spring's proposed plan and recommendations regarding the use of the \$600,000 in NEA funds was approved by the State of Florida. The plan provides grant funds to State of Florida grantees for fiscal year 19-20. The Department of Cultural Affairs has encouraged all eligible Miami-Dade County organizations to apply for the funding.

### **Federal Arts Budget Update**

Ms. Leslie reported that Congress responded to national advocacy by providing an additional \$75 million in recovery funding to the National Endowment for the Arts (NEA) through the Coronavirus Aid, Relief, and Economic Security (CARES) Act. The National Endowment for the Humanities also received an additional \$75 million in recovery funding. A total of 40% of the funding allocated to the NEA is directed to state arts councils.

### **Department Facilities Updates**

#### **Status Report**

Ms. Leslie reported that the Department's capital projects team is very busy as construction activity at the facilities continues at a brisk pace now that they are closed to the public. The African Heritage Cultural Arts Center launched virtual summer camp classes that are free to the public. The Miami-Dade County Auditorium's renovation work

continues. The Auditorium is getting ready to launch the Drive-Through Theatre Experience, a new program where the audience remains in their cars for a quick ten-minute performance in the parking lot of the facility. The program will launch in July. The South Miami-Dade Cultural Arts Center continues to develop plans for its future café. The virtual program, SMDCA Sessions, continues to feature a variety of artist performances on Thursday evenings via Facebook Live.

### **Westchester Cultural Arts Center**

Ms. Leslie reported the project finalized the building permit review process and work is starting on the site. A groundbreaking event is being held with Miami-Dade County Commissioner, Senator Souto, District 10 and the Miami-Dade Parks Department on Friday, June 26, 2020. The Center will be located at the Bird Road entrance to Tropical Park, and will feature a black box theatre with 125-150 seats, including a significant lobby that will function as an art gallery and potential meeting space.

### **Coconut Grove Playhouse**

Mr. Leslie reported that oral arguments for Miami-Dade County's petition to the Appellate Division of the Circuit Court of the Eleventh Judicial Circuit appealing the City of Miami Mayor's veto of the County's application for a final Certificate of Appropriateness for the Coconut Grove Playhouse were heard on June 16, 2020. The Court has yet to issue a ruling.

### Art in Public Places Update

Ms. Amanda Sanfilippo Long reported that Art in Public Places Program (APP) currently has over 80 commissions in production and 30 in the planning phase, 3 temporary commissions are in the planning phase and 3 restorations are currently in progress. Ms. Sanfilippo Long provided the artist shortlist for VOX Miami at South Miami Metrorail Station: Jennifer Basile, Loriel Beltran, Eugenio Espinosa, Kelley Johnson, Amanda Keeley, R & R Studios, Christina Lei Rodriguez, Tom Scicluna, with alternates Leo Castaneda and Westen Charles. Art in Public Places is working on the upcoming artist calls for Amelia Earhart Park, Miami-Dade County Parks, Recreation and Open Spaces; Gallery on the River with the Miami-Dade Public Housing and The Related Group; and a national artist call for the Virgin Cruise Terminal at PortMiami.

#### **DIRECTOR'S REPORTS**

- Ms. Leslie announced that Cultural Affairs Council members are required to compete Source of Income Statement forms and as necessary Gift Disclosure forms. Forms are due July 1 are to be submitted to the Miami-Dade Elections Department.
- Mr. Spring has been participating in reopening team calls with Mayor Gimenez. Mr. Spring has been directly
  involved in reviewing reopening plans for cultural institutions that have received permission to open provided
  they submit a plan for Miami-Dade County's review and approval.
- The Department of Cultural Affairs received two National Association of Counties Awards: African Heritage Cultural Arts Center's Artist Residency Program and Art in Public Places for the public artwork at Caribbean Village.
- The Children's Trust voted to continue the partnership with the Department of Cultural Affairs and renewed the funding of \$1.5 million dollars for FY 20-21.

Mr. Trieger left the meeting at 12:48 p.m.

#### **COUNCILOR REPORTS**

- Chairman Cortada would like to see the Department of Cultural Affairs and the Council engage in a conversation
  and look at inclusivity and equity in our work. Miami-Dade County has largely experienced the demographic shift
  that is now taking place around the country 30 years ago and now is a good time to review how our work is
  addressing racial injustice. He was also very proud to see the landmark Supreme Court ruling to prevent job
  discrimination on LGBTQ members of society.
- Ms. Sugrañes stated she has been moved by protests happening all over the Country and supports the the
  review the Council's work addressing racial equity.
- Mr. Henriques stated that he participated in a virtual "Zoom gala" that featured a performer. He got a lot out of it and had an opportunity to interact and exchange ideas in a new way.
- Ms. Chancy-Gonzalez thanked the Chairman for championing the idea of looking at the Departments' and Council's work. She stated she has thoroughly enjoyed participating in the panel review process.
- Ms. Sigars-Malina reported Miami City Ballet is having virtual performances and Fairchild Tropical Botanic Garden is conducting plant and mango sales online.
- Mr. Monty Trainer stated he would like to see something cultural happen in the West Grove, which was originally very artistic.

Mr. Spring joined the meeting at 1:04 p.m.

# Miami-Dade Artist Support (MÁS!) Grants Program

Mr. Spring reported that on the Department of Cultural Affairs recently launched the Mami-Dade Artists Support! (MÁS!) Grants Program in response to the COVID-19 pandemic. The Department is partnering and has the support of the Jorge M. Pérez Family Foundation, which donated \$100,000 to match the County funds. Mr. Spring thanked Mr. Pérez and Mr. Henriques for their work to get the matching funds approved and expedited to help artists impacted by the health crisis. He believes this program really highlights the needs of artists currently and hopes this serves as a model and will continue to share information with partner foundations in the community.
