FY 2021 – 2022 Summer Arts & Science Camps for Kids (SAS-C) Grants Program Guidelines

Mr. Spring reported that starting in FY 2021-2022, organizations that receive direct grant support from The Children's Trust under the Youth Development Initiative will no longer be eligible to apply to the Summer Arts & Science Camps for Kids (SAS-C). FY 2021-2022 Community Grants (CG) Program Panel Recommendations – First Quarter

Mr. Spring reported the FY 2021-2022 Community Grants program panel, co-chaired by Councilors Sandra Curbelo and Janá Sigars-Malina, convened on August 26, 2021 to review 20 applications for the first quarter of the program. The Community Grants Program is responsive on a quarterly basis to organizations, which develop small and large-scale community-based programs, projects, events, and publications. The Panel recommended funding 20 applicants for a total of \$150,000.00. No Councilor conflicts of interest were identified. A motion was made to fund all the of the panel's recommendations. FY 2021-2022 Major Cultural Institutions (MCI) Grants Program Recommendations

Mr. Spring reported that Department's program staff determined it was not necessary to convene a panel meeting this year as all organizations supported through the Major Cultural Institutions (MCI) grant program have met all program requirements and continue to demonstrate their resilience during our most challenging time. This is an interim cycle for MCI grant recipients, as the program operates on a four-year review cycle. Funding for the program is derived from departmental proprietary revenues and all recommendations are contingent upon approval of the Department of Cultural Affairs' FY 2021-2022 budget and are calculated based on the funding formula.

FY 2021-2022 Youth Arts Enrichment (YEP) Grants Program Panel Recommendations

Mr. Spring reported that the FY 2021-2022 Youth Arts Enrichment Program (YEP) grants panel, chaired by Mireille Chancy-Gonzalez, convened on August 25, 2021, to review applications. The Panel recommended funding 29 applications for a total of \$550,000.00. The program was created as a joint initiative with the Department's longtime partner, The Children's Trust. The objective of the Youth Arts Enrichment grants program is to improve the lives of children through the arts by making the arts available to more children and families. Funding for the program is derived from the FY 2021-2022 grant awarded to the Department by The Children's Trust. All recommendations are contingent upon approval of the Department of Cultural Affairs' FY 2021-2022 budget.

FY 2021-2022 Grants Programs Panel Recommendations

Mr. Spring presented the aggregate of all grants programs panel recommendations that will be adopted as part of the budget process. Mr. Spring reported that Miami-Dade County Mayor Levine Cava proposed the FY 2021-2022 County budget and recommended renewal of funding for the Department of Cultural Affairs. The recommendation includes the approved subsidy for Roxy Theatre Group to manage the Westchester Cultural Arts Center and a \$340,000 increase to the Department's budget to restore funding for arts education programs, for Culture Shock Miami, and for professional development workshops to improve artists' business skills. A motion was made to approve the Grants Program Panel Recommendations. (Motion by Mr. Henriques; seconded by Ms. Sigars-Malina)

Director's Report

- Mr. Spring reported that at the first Budget Hearing the Board of County Commissioners voted for the millage rate that was set by the County Commission in July. The Commission will finalize the millage rate and the FY 2021-2022 budget at the 2nd and final public hearing on Tuesday, September 28th. During the public testimony, support was expressed for the \$500,000 subsidy in the Mayor's budget for the Historic Hampton House. There was no public comment on the Department's overall budget. Mr. Spring recognized Councilor Mitchell Bierman's attendance at the hearing.
- The Department submitted three grant applications to the SBA's Shuttered Venue Operators Grant program. The Department received awards to benefit Miami-Dade County Auditorium, the South Miami-Dade Cultural Arts Center, and the African Heritage Cultural Arts Center. The Department received an invitation to apply for a second round of funding. Staff promoted the opportunity widely and an analysis showed Miami-Dade County cultural groups secured 21% of all Florida awards.
- Mr. Spring reported that Miami-Dade County's court appeals have been filed for the Coconut Grove Playhouse project. Miami-Dade County Mayor Levine Cava and Commissioner Regalado are promoting the County Playhouse plan and will host a Zoom community meeting to provide the latest updates to public in early October.
- Department staff member Graham Winick has been promoted and is now the new Chief of Administration.

Councilor Reports

• Mr. Bierman reported that he visited many galleries during his stay in New York. He noted that many exhibitions featured artists from the African and Caribbean Diaspora, and Franklin Sirmans and the Pérez Art Museum Miami are recognized as having put us on the map in a significant way.

- Ms. Sigars-Malina reported that the Fairchild Tropical Botanic Garden has family-friendly events happening at the garden. She also recognized the work of Rosie Gordon Wallace.
- Mr. Trieger reported that the New World Symphony is scheduled to have its first in-person audience since March 2020.

With no further business, the meeting was adjourned at 10:35 AM.
